1.2 MANAGEMENT AND SCIENCE UNIVERSITY ROLE AND CONTRIBUTION

- a. To arrange for MSU lecturers to deliver lectures to POLJIE students.

2. DURATION

The program is carried out for one (1) day, which starts on 6th December 2024 depending on mutual agreement on both parties.

3. FINANCIAL ARRANGEMENT

The parties acknowledge that in the absence of any specific arrangement in writing to the contrary, each party shall be responsible for its own costs and expenses in establishing and conducting programs and activities contemplated under this IA, including its costs and expenses in travel and accommodation.
