On this day, Date twenty-fifth Month November, Year Two Thousand Twenty Four (November 25<sup>th</sup>, 2024) the undersigned :

**1. Saiful Anwar, S.TP., M.P.**

Director of Politeknik Negeri Jember, located on Mastrip Street 164, Sumbersari District - Jember Region, in this case as and on behalf of Politeknik Negeri Jember, hereinafter referred to as **FIRST PARTY**.

**2. Dr. Tang Yen-Po**

President of St. John's University, located on No. 499, Sec. 4, Tam King Road, Tamsui, Taipei, Taiwan in this case as and on behalf of St. John's University, referred to as **SECOND PARTY**.

Further in this Memorandum of Understanding **FIRST PARTY** and **SECOND PARTY** called "**THE PARTIES**" and individually called "**PARTY**".

**THE PARTIES** will explain the following matters previously:

1. **FIRST PARTY** is Vocational Colleges with skill competency on Agricultural production, Agricultural Technology, Animal Husbandry, Agribusiness Management, Information

Technology, Language, Communication and Tourism, Health Department, Engineering and Business Departments;

2. **SECOND PARTY** is Technology University that focuses on the department of Engineering, Mechanical and Vehicle Engineering, Information Engineering, Industrial Management, Management Information, Multi-Media Design, Business Administration, Leisure & Sports and Tourism Management, Senior Welfare and Health Promotion, Applied English, Marketing and Channel Management.

The parties are desirous of entering into this Memorandum of Understanding and involved will share their academic interest and resources, declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties upon the terms as contained herein, engaging in collaboration to promote mutually advantageous cooperation in academic activities aimed at qualified human resources. To extent feasible, the parties will develop programs and activities of cooperation between their students, faculty members, departments and research institutes to exploring education, research and cultural exchange.

The possible programs and activities between the two institutions may include:

- a. Development of joint courses and education programs.
- b. Cooperate to foster outstanding graduates to attend Colleges/University,
- c. To exchange students, teachers, lecturers and the others staff of both parties.
- d. Cooperation in the field of research.
- e. Online Collaborative Teaching and learning (Digital Class)
- f. To conduct Joint Research, International Seminar, Conference, Internship, Symposium and Workshop.
- g. To execute separate agreements in writing for any particular undertaking jointly implemented, wherein sharing of responsibilities shall be specified and approved by both parties.

The details of all activities, including new suggestions that are not reflected in this memorandum, may be proposed and implemented on the basis of agreements to be signed by both institutions.

This Memorandum of Understanding may be amended at any time by mutual consent and will be effective for a period of five years commencing from the date of signature after which, it will automatically be extended for another five years unless one of the institutions seeks to terminate it through by written notice one year prior to expiry.


