Director of Politeknik Negeri Jember, located on Mastrip Street 164, Summersari Sub-District - Jember Regency, in this case as and on behalf of Politeknik Negeri Jember (POLIJE), hereinafter referred to as **FIRST PARTY**.

2. Asst. Prof. Chakrit Chanchitpreecha

President, located on 680 Nittayo Road, Mueang District, Sakon Nakhon 47000, Thailand in this case as and on behalf of Sakon Nakhon Rajabhat University, Thailand referred to as **SECOND PARTY**.

Further in this Memorandum of Understanding **FIRST PARTY** and **SECOND PARTY** are called "**THE PARTIES**" and individually called "**PARTY**".

THE PARTIES will explain the following matters previously:

1. **FIRST PARTY** is Vocational Colleges with skill competency in Agricultural Production, Agricultural Technology, Animal Science, Agribusiness Management, Information Technology, Language, Communication and Tourism, Health, Engineering and Business Departments
2. **SECOND PARTY** is University that focuses on produce quality and ethical teachers and graduates to serve the local community and other communities, Foster research and innovation to develop knowledge and transfer it for the development of the local community and other communities, provide academic services and transfer technology to the local community or other communities, preserve and promote arts and culture to create values and significance for the local community and other communities and manage and govern with integrity and transparency to ensure quality.

The parties are desirous of entering into this Memorandum of Understanding and involved will share their academic interest and resources, declare their respective intentions, and establish a basis of co-operation and collaboration between the Parties upon the terms as contained herein, engaging in collaboration to promote mutually advantageous cooperation in academic activities

aimed at qualified human resources. To be feasible, the parties will develop programs and activities of cooperation between their students, faculty members, departments, and research institute to explore education, research, and culture exchange.

The possible programs and activities between the two institutions may include:

- a. Joint research activities
- b. Exchange of information in science education and research which is of mutual interest to both SNRU and POLIJE
- c. Exchange of department members for research, lectures, and discussions
- d. Exchange of graduate and undergraduate students for study and research
- e. Access to the various facilities of each institute
- f. Exchange the global partnership for the Sustainable Development Goals (SDGs).
- g. Other activities mutually as may be agreed by the two universities.

The details of all activities, including new suggestions that are not reflected in this memorandum, may be proposed and implemented on the basis of agreements to be signed by both institutions.

This Memorandum of Understanding may be amended at any time by mutual consent and will be effective for a period of five years commencing from the date of signature after which, it will automatically be extended for another five years unless one of the institutions seeks to terminate it through by written notice one year prior to expiry.
